

PUBLICATION POLICY

Meteorologica publish papers describing results of new research in meteorology, oceanography and their applications (see dual and prior publication policies for more details). Extensive reviews of a particular topic in these fields as well as short notes describing new data sets or tools will also be considered.

Meteorologica publish only original material that was not published before or that is considered for publication elsewhere, except in the form of an abstract, extended abstract or proceedings-type publication.

Prior publication

Meteorologica will not accept material that has been previously published in any form that constitutes public distribution. Specifically, any document that is accessible to a library user, who does not have special access or privileges, directly or indirectly in paper or electronic form is considered published, except as noted below.

Previously published explicitly does not include oral or poster presentations, meeting abstracts, meeting extended abstracts or student theses/dissertations. Any other online publication with a service that provides archiving with citation protocols and public retrieval capabilities constitutes prior publication. Publication of an article in any language prior to submission to Meteorologica constitutes dual publication. Other exceptions of postings or publications required for legal or other reasons may be considered at the discretion of the editors.

If a paper under review is found to have been previously published somewhere else, the paper will be rejected. If prior publication is detected in a paper published by Meteorologica the article can be withdrawn from the journal (see Electronic Correction Policy)

Dual submission

Meteorologica will not consider for publication a manuscript that is under review in another peer reviewed journal with the same basic scientific content reaching the same fundamental conclusions. This does not prohibit the submission to Meteorologica of a manuscript that has been rejected by another peer reviewed journal as long as that original submission and review process has been completed.

If dual submission of a paper is detected during the review process, the paper will be rejected, if dual submission is detected in a paper published by Meteorologica the article can be withdrawn from the journal (see Electronic Correction Policy)

Plagiarism and self-plagiarism

Centro Argentino de Meteorologos and Meteorologica do not accept plagiarism and self plagiarism, considering it a serious misconduct.

If a section of the paper, figure or table is found to be copied from other sources without properly acknowledging the original author it will be considered plagiarism. Note that this can also apply to papers that have been previously published by the same author (i.e. self-plagiarism). To avoid plagiarism, always include quotes and cite the original source, when parts a sentence length or larger from other sources is being reproduced within a manuscript. Changing some aspects of a text (e.g. modifying some words or changing verb tenses is still considered plagiarism).

Recall that even if the original source is cited a permission must be requested to the copyright holder under some circumstances (e.g. when a figure from another paper is included in the manuscript or when the length of the quoted text is longer than a paragraph).

If plagiarism or self-plagiarism is detected in a paper submitted to meteorologica the editorial committee will decide the actions to take. If plagiarism is detected on a small part of the document the editors will recommend including appropriate citations, if a significant part of the paper is found to be reproduced without proper acknowledging the authors the paper might be rejected. If plagiarism or self-plagiarism is detected in a paper published by Meteorologica the article can be withdrawn from the journal (see Electronic Correction Policy)

Fabrication

Centro Argentino de Meteorologos and Meteorologica do not accept fabrication of data and / or results, considering it a serious misconduct.

Fabrication is making up data or results and recording or reporting them. Fabrication does not include documented use of modeling or statistical techniques.

If data or result fabrication is detected during the review process the paper will be rejected. If fabrication is detected in a paper published by Meteorologica the article can be withdrawn from the journal (see Electronic Correction Policy)

Falsification

Centro Argentino de Meteorologos and Meteorologica do not accept falsification of data and / or results, considering it a serious misconduct.

Falsification is manipulating research materials, equipment, or processes or changing or omitting data or results such that the research is not accurately represented in the research record. Falsification does not include errors of judgment; honest errors in the recording, selection, or analysis of data; or differences in opinions involving the interpretation of data.

If falsification is detected during the review process the paper will be rejected. If falsification is detected in a paper published by Meteorologica the article can be withdrawn from the journal (see Electronic Correction Policy)
